

THE APPLICATION FORM RELATED TO LAW ON THE PROTECTION OF PERSONAL DATA

I. Your Rights

Pursuant to the Article 11 of Law on the Protection of Personal Data numbered 6698 (“LPPD”), everyone, in connection with herself/himself, has the right to;

- Learn whether or not her/his personal data have been processed,
- Request information as to processing if her/his data have been processed,
- Learn the purpose of processing of the personal data and whether data are used in accordance with their purpose,
- Know the third parties in the country or abroad to whom personal data have been transferred,
- Request rectification in case personal data are processed incompletely or inaccurately,
- Request deletion or destruction of personal data within the framework of the conditions set forth under article 7,
- Request notification of the operations made as per indents (d) and (e) to third parties to whom personal data have been transferred,
- Object to occurrence of any result that is to her/his detriment by means of analysis of personal data exclusively through automated systems,
- Request compensation for the damages in case the person incurs damages due to unlawful processing of personal data,

by applying to the data controller.

II. Your Application Request

Herein this application form is drafted by our Company in order to transfer your requests related to enforcement of LPPD and be able to have applied the determined methods of claiming your rights related to protection of your personal data's to you effectively. According to this, your applications made in order to exercise your rights by LPPD are necessary to be transferred to our Company's registered e-mail;

- Within registered letter with return receipt,
- Through a notary public,
- And signed with “secure electronic signature” which is defined in Electronic Signature Law Numbered 5070.

As mentioned above, pursuant to Article 13 of LPPD, the applications made by you shall be responded within 30 (thirty) days from the transmission date to our Company in written or electronically. Our Company reserves the right to request additional document and information for identification in order to eliminate the legal risks caused by illegal as well as unlawful data sharing actions and especially provide the security of your personal data's. Hence, transmitting the relevant form correctly, completely and as contained the demanded information and documents is of vital importance.
